CONVALESCENT ENDOWMENT FUND

The Convalescent Endowment Fund (CEF) is our irrevocable trust fund, the assets of which remain in perpetuity working to create income for the Convalescent Relief Fund (CRF). This fund is the workhorse of our charitable endeavors and gift-giving. By increasing our endowment fund assets, we significantly and automatically increase the value of our Relief Fund. Focusing on giving to the Endowment Fund strengthens our philanthropic financial bases. The more we give to Endowment, the more income we can contribute to Shriners Hospital for Children® - Canada.

CEF and CRF in Canada make up the Canadian Foundation—a recognized registered foundation.

CONVALESCENT RELIEF FUND

The Convalescent Relief Fund (CRF) is our ready NOW fund — the vehicle we use to extend our monetary support to the outpatient children of Shriners Hospital for Children® - Canada each year. Donations from individuals and Subordinate Temples are made to the Relief fund throughout each fiscal year, providing a remarkable accumulation of assets for our annual gift to Shriners Hospital for Children® - Canada.

Making a Difference Through Giving

There are many ways you can help the special children of Shriners Hospitals for Children® - Canada through the Daughters of the Nile Canadian Foundation. With *Making a Difference* through planned giving, you can help children while enjoying a tax benefit.

A gift made during your life or though provisions in your will, regardless of size, is welcome and sincerely appreciated.

The Convalescent Relief Fund (cash donation)

- A \$25.00 donation to the CRF qualifies anyone to receive a NOW certificate. These certificates are available in one of two categories: "In Honour of" and "In Memory of". NOW certificates may be framed and make wonderful gifts.
- Direct giving to the CRF offers a one-time charitable contribution. This gift will be sent to the Shriners Hospitals for Children® - Canada during the fiscal year it is received.

The Convalescent Endowment Fund (irrevocable trust)

- Direct giving to the CEF also offers a one-time charitable contribution. At the same time, this gift will perpetually earn monies that will be contributed to the children each and every year.
- A \$25.00 donation to the CEF qualifies anyone to receive a Stepping Stones to Happiness certificate. These certificates are available in one of two categories: "In Honour of" and "In Memory of". Stepping Stones certificates may be framed and make wonderful gifts.
- My Gift Incentive Program offers incentive gifts that are both affordable and available in all price ranges. The donation portion that exceeds the fair market value of the gift received is eligible for tax credit and a Canadian tax receipt will be issued. - A bequest to the CEF should be provided for in a specific manner, whether it is for specific monetary value, the residue of your estate, as a contingent gift or by earmarking the fund to be the beneficiary of a life insurance policy. As a significant donor, you will want your gift to be handled correctly; therefore, on the adjacent panel a variety of examples are provided. **REMEMBER**, please consult with your personal legal counsel, expert or legal advisor in your locality before adding to or changing your will.

Common examples of how to remember the Canadian Foundation in your Will or Trust:

1. SPECIFIC BEQUEST

I give and bequest (\$_____
specific dollar figure or description of property) to the Convalescent Endowment Fund of the registered charity whose legal name is "Supreme Temple Daughters of the Nile Convalescent Relief Fund and Supreme Temple Daughters of the Nile Convalescent Endowment Fund" and whose alternate name is the *Canadian Foundation*. My Gift shall be used at the discretion of the Trustees of the Canadian Foundation.

2. PERCENTAGE BEQUEST

I give and bequest (_____% of my estate or trust) to the Convalescent Endowment Fund of the registered charity whose legal name is "Supreme Temple Daughters of the Nile Convalescent Relief Fund and Supreme Temple Daughters of the Nile Convalescent Endowment Fund" and whose alternate name is the *Canadian Foundation*. My Gift shall be used at the discretion of the Trustees of the Canadian Foundation.

3. RESIDUARY BEQUEST

I give and bequest the remainder of my estate or trust to the Convalescent Endowment Fund of the registered charity whose legal name is "Supreme Temple Daughters of the Nile Convalescent Relief Fund and Supreme Temple Daughters of the Nile Convalescent Endowment Fund" and whose alternate name is the *Canadian Foundation*. My Gift shall be used at the discretion of the Trustees of the Canadian Foundation.

4. CONTINGENT BEQUEST

I give and bequest my assets to my spouse, if my spouse survives me, and if he/she predeceases me, I give my assets to the Convalescent Endowment Fund of the registered charity whose legal name is "Supreme Temple Daughters of the Nile Convalescent Relief Fund and Supreme Temple Daughters of the Nile Convalescent Endowment Fund" and whose alternate name is the *Canadian Foundation*. My Gift shall be used at the discretion of the Trustees of the Canadian Foundation.
